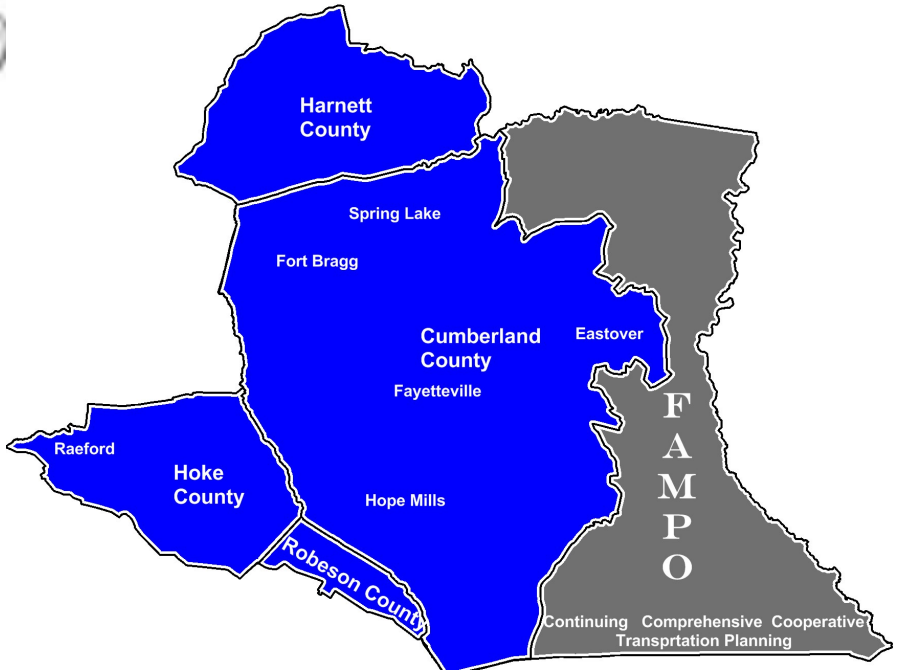
Project Prioritization SPOT 4.0

The Fayetteville Area Metropolitan Planning Organization has been diligently working on prioritizing transportation projects for the State of North Carolina's Strategic Transportation Investment program. Currently, the Regional level of prioritization is being approved (see page 2) and the Division level is being distributed for public review.

Public meetings will be scheduled throughout the MPO area for public feedback and the ranking information will be posted on FAMPO's website (www.fampo.org).

The draft list of funded projects and their timeframe for construction should be released this Winter.

New Segments of the Fayetteville Outer Loop Opening

New pieces of the Fayetteville Outer Loop will open up before the end of the year. The Ramsey Street to Murchison Road connection is scheduled to open on August 11. This will create a full connection between Bragg Boulevard and I-95. Later this year, the segment from Bragg Boulevard to the All-American Freeway is scheduled to also open.
