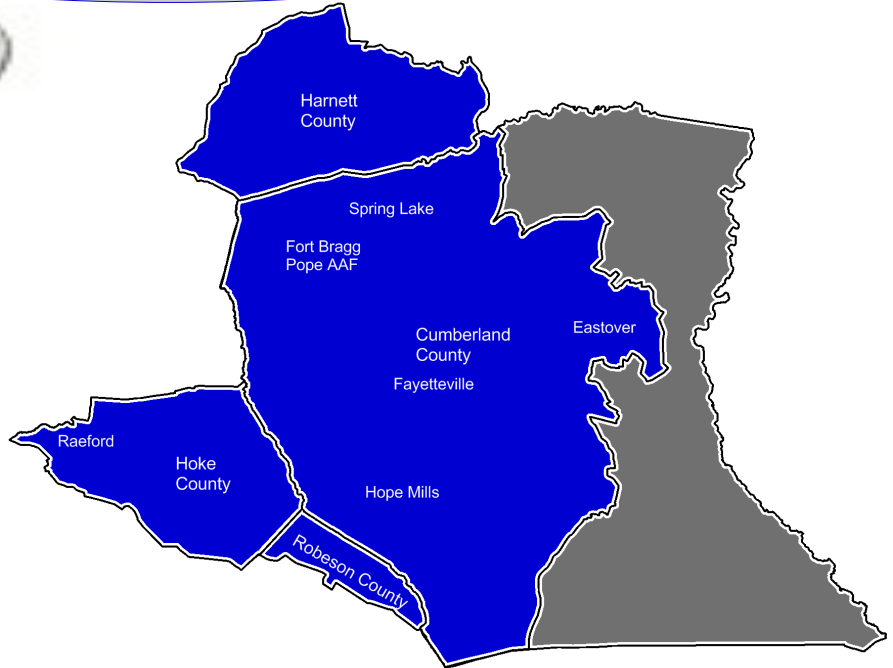


## FAMPO Planning Area Expands based on 2010 Census

You may have noticed that our logo looks a little different than previous newsletters. This is because the Fayetteville Urban Area expanded based on the 2010 Census. Correspondingly, our Metropolitan Planning Area (MPA) also expanded.

Now included in the MPA are larger portions of Cumberland, Harnett, and Hoke Counties, along with the Town of Raeford and a portion of Robeson County that includes the Town of Parkton.

Our Urban Area has grown from a total population of 276,368 in 2000 to 310,282 in 2010, a total of 33,914 or about 12.5%.



## Bragg Boulevard Plan focuses on transportation

The City of Fayetteville recently completed the Draft Bragg Boulevard Corridor Redevelopment Plan. This area is expected to grow over the next 20 years, setting the stage for an improved transportation system connecting Fort Bragg and downtown Fayetteville. 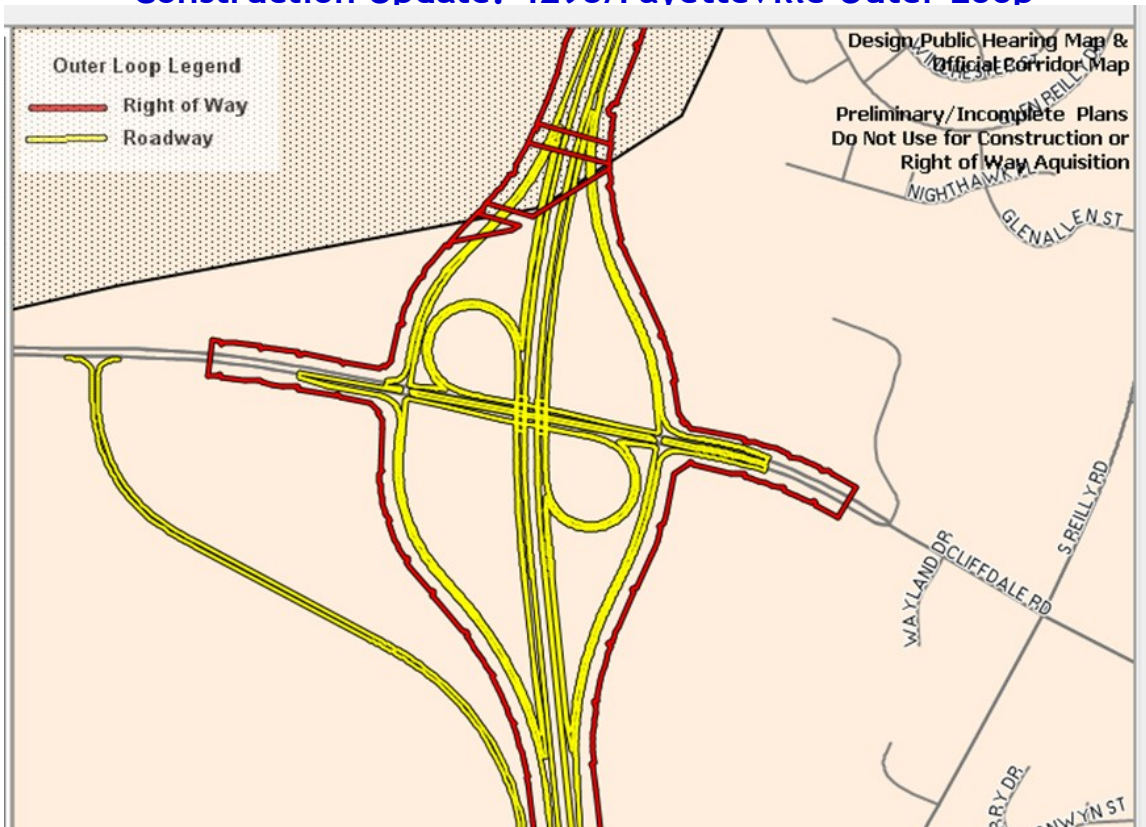

## Construction Update: I295/Fayetteville Outer Loop

In September the N.C. Board of Transportation approved funding for another section of the Fayetteville Outer Loop. The Board approved \$104.6 million to extend the Outer Loop to Cliffdale Road in Western Fayetteville. Construction should begin in 2014. ## New Transit Pilot Project

Cumberland County Commissioners approved a new pilot project in September to provide transit from the Cedar Creek community to the Transfer Center operated by the Fayetteville Area System of Transit (FAST).

The 15 passenger van will make two round trips daily, twice in the morning and twice in the evening, from the corner of Tabor Church and Cedar Creek Road to the Transfer Center. Service is expected to begin on October 15th and continue for at least 90 days, after which the service effectiveness will be evaluated.
